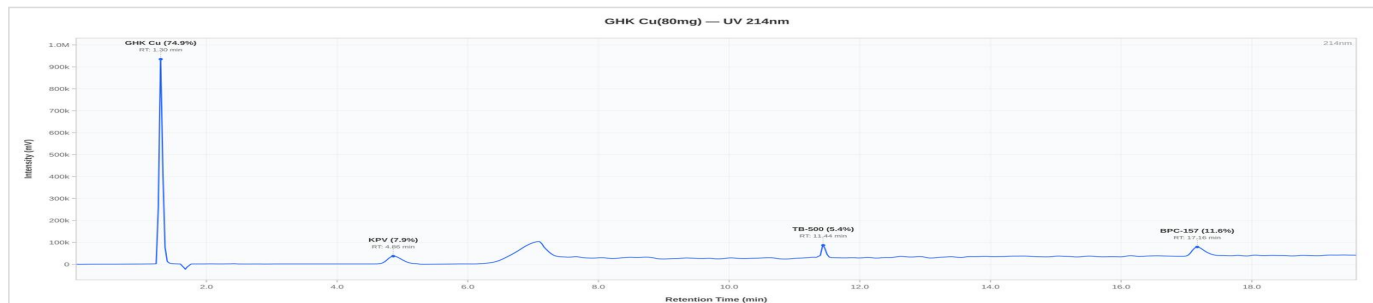

Notes & Methodology

- Date Tested: 07/24/2026. Methods: Blend Purity, Identity & Quantitation (HPLC).
- The sample was confirmed to be GHK-Cu / TB-500 / BPC-157 / KPV by HPLC. Identification by chromatographic retention time comparison with a reference standard.
- Peptide purity determined by RP-HPLC area normalization at 214 nm. Value represents the percentage of the target peptide relative to all peptide-related peaks. Non-peptide process-related impurities, if detected, are excluded from the calculation.
- Per-component content calculated from total net peptide content using the manufacturer's stated formulation ratio (GHK-Cu, BPC-157, TB-500, KPV). All components confirmed present by HPLC identity testing, unless explicitly stated otherwise.
